



How quickly can I get a car or van delivered?

For accident or breakdowns, vehicles can be delivered within 8 hours. Otherwise, it's 24-48 hours for standard vehicles and 5 days for EVs. You can also arrange collection from the nearest branch.

Are the vehicles fully sanitised?

To create a safer working environment for your employees, every vehicle is fully cleaned and sanitised between every rental.

Will each rental result in extra invoices to process?

Can I cut the contract short, or extend it if necessary?

Rentability vehicles can be returned with just 24 hours notice and we will simply charge the relevant daily hire rate. Rentability+ vehicles need to pass their minimum rental period and can then be returned at any time.

Is there a mileage limit?

Every vehicle comes with a mileage allowance of 2,800 per 28-day period. Additional mileage can be applied at 30p per mile over the standard mileage allowance.
